With a view to providing reliable trade information to Indian exporters and overseas buyers, the trade portal of ITPO : www.tradeportalofindia.org has also been set up which provides information on 102 countries including 27 countries of European Union. The facilities to ITPO members, include access to Kompass data base containing details of manufacturers/ importers/ exporters/ agents/ departmental stores/ distributors/ wholesalers/ traders in respect of more than 66 countries. Kompass contains data base of more than 5 million companies searchable and classified by around 58,000 product and service categories.
