OFFICE ORDER NO. ADMIN/25/2015

The Competent Authority has approved Restructured Medical Benefit Scheme for ITPO Employees. The salient features of the approved scheme are as follows:

- 1- ITPO will follow a non insurance based medical scheme w.e.f. 04.03.2015 to 31.03.2016.
- 2- ITPO will bear actual expenses on account of hospitalization and diagnostic tests through CGHS empanelled hospitals and labs on cashless basis.
- 3- The entitlements for hospitalization shall be as per the medical attendance rules of ITPO which were applicable prior to introduction of insurance based policy.
- 4- For OPD/general treatment 1/12th of one month Basic pay will be paid along with along with monthly salary.
- 5- The overall ceiling of perks and allowances is 45% of basic pay instead of 50% of basic pay and it is inclusive of OPD charge. Employees have an option of availing remaining perks under cafeteria approach.
- 6- Employees are requested to give their option of Perks and Allowances as per the Annexure A.
- 7- Medical facilities can be availed from Government Hospitals also.
- 8- Information upon Hospitalization may be sent to medical@itpo.gov.in.
- 9- A consolidated list of hospitals and diagnostic centres along with procedural steps to be followed upon hospitalization is at Annexure B.

Note:

- Expenses incurred on the following dental treatment (A) Filling of teeth, (B) Scaling and Gum treatment, (C) Extraction, and (D) Root Canal Treatment will fall under OPD/General treatment category and not under hospitalization.
- Office order dated 04.03.2015 stands withdrawn with immediate effect.

PROCEDURAL STEPS

For Hospitalisation

I.

- Employee will inform Administration about admission in the hospital or give prior intimation in case the date of admission is decided in advance. Information may also be sent to medical@itpo.gov.in.
- 2. Personal Section will forward the intimation to Vigilance Division also.
- 3. Employee will forward the estimated expenditure from the hospital.
- ITPO will issue an approval letter for the estimated expenditure approving treatment of the patient in the hospital. Copy of the same is given to Medical Unit.
- After completion of treatment, the hospital will raise final invoice and send the same to Medical Unit alongwith original copy of the sanction for processing the payment.
- The payment is processed by the Medical Unit and cheque will be dispatched to the hospital.
- 7. In case the patient is required to remain in hospital beyond the approved period or there is any additional expenses involved on account of medical procedure, the revised estimate will be got prepared and send to ITPO for fresh approval for the revised period.
- The admission will be done subject to production of Medical Identity Card of the patient (employee or his/her dependent).

In case the total amount exceeds these limits for same admission, the file may be sent to higher level (as per DFPR)

For Tests

Employees may avail the facility of Pathological tests on production of Medical Identity Card issued by ITPO (in case the card is not available for any reason, some other card confirming identity of the person like Driving License, Photo I.D. Card, Employer Card, School/College ID, Ration Card, Aadhar Card, Birth Certificate for infants).

However, for major tests involving expenditure of over Rs. 2,500/- like Cat Scan, MRI etc. will not be done without taking prior approval of the Administration and same procedure as in the case of hospitalization shall be followed.

ITPO will also develop a system that the medical facility is not being misused, in case it is found that any employee has misused the facility, stern action will be taken against him/her.

Norms for Path Labs

- a) Test will be subject to proper prescription from a MBBS Doctor.
- b) The labs will entertain employees on the basis of production of Medical Identity Card of his or her dependents for whom the test is to be conducted.
- c) The employee will give intimation over phone or through e-mail to the office on the same day or next working day.
- d) Confirmation letter will be sent by ITPO on receipt of information from the Path Lab.
