- 2. The Trade Magazine should have minimum circulation of 25,000 copies.
- 3. The Trade Magazine should have circulation all over India.

BARTER AGREEMENT – BETWEEN ITPO AND PUBLICATIONS/MAGAZINES FOR IISE 2016.

OBLIGATIONS OF TRADE MAGAZINES.

- 1. The publication will provide one full page advertisement of IISE 2016 in each issue of their magazine succeeding issue of magazine from the date of signing the agreement. The magazine will be required to publish total six advertisements of IISE 2016 whether in their monthly or bi-monthly issues, as the case may be. Magazine will be bound to carry all six advertisements of IISE 2016 depending on the nature of issue i.e. monthly/bi-monthly. To begin with, it will carry advertisement for IISE 2016 advertisement for followed bv announcement mobilization of IISE 2017. In all total six advertisement have to be published by the publisher in each case. artwork of advertisement for IISE 2016 and IISE 2017 will be provided by ITPO.
- 2. Magazine will publish post-show report of the fair with contents duly approved by ITPO.
- 3. Magazine will pay service tax @ 14.5% or as applicable on notional value of the cost of built-up booth of 9 sq.mtrs. i.e. Rs.72,000/- at the time of signing of the barter deal agreement.
- 4. Magazine will also pay 2% TDS on the notional value of the booth i.e. Rs.72,000/- at the time of signing of Barter Deal agreement.
- 5. The publication will submit to ITPO three copies of each issue of magazines, in which the advertisement has been published for record and accounting.

Obligations of ITPO.

- 1. One 9 sq.mtr. built up booth with partition panels, one table, two chairs, spot lights, one power point plug and one waste paper basket during IISE 2016. Layout plan/location of stall will be decided by ITPO.
- 2. Free entry of Profile of publisher as participant in the IISE 2016 Fair Catalogue.
