India Trade Promotion Organisation (ITPO), the premier trade promotion body of the Government of India, is organizing the 1st Mumbai edition of its flagship event "Aahar - The Food & Hospitality Fair", at CIDCO Exhibition Centre, Vashi, Navi Mumbai from October 11 - 14, 2017. This will be the first show of its kind in western region of India.

- AAHAR, India's most vibrant Food & Hospitality Event, has grown to be the premier show of the industry and the 32nd edition oganised from March 7-11, 2017 at Pragati Maidan, New Delhi attracted Hoteliers and Restaurateurs, Manufacturers, Wholesalers and Retailers of Food, Bakery & Hospitality Products. As many as 1048 exhibitors, including 92 foreign companies from 19 countries, such as, USA, China, Canada, Germany, Italy, Switzerland, Russia, Poland, Turkey, Bulgaria, Spain, Oman, Korea, Sweden, Thailand, UAE, Peru and Lebanon participated in the Show. The show had an attendance of more than 67,500 visitors from India and abroad.
- AAHAR Mumbai is being organized with the support of the Ministry of Food Processing Industries, Government of India & APEDA. Trade & Industry Associations are fully associated with the Show, which include Food & Hospitality Support Association of India (FHSAI), All India Food Processors Association (AIFPA); Hotel and Restaurant Equipment Manufacturers Association of India (HOTREMAI); Association of Resource Companies for the Hospitality Industry of India (ARCHII) and Forum of Indian Food Importers (FIFI).
- Indian hospitality sector is clocking CAGR of 14%. According to the World Tourism Organisation, 15.3 million foreign tourist arrivals are expected in India by 2025. This will create a huge demand for the hospitality sector. The foreign investors are tapping this opportunity in a big way. According to DIPP, the amount of FDI inflow in the industry during the last couple of years was more than US\$ 6 Billion.
- AAHAR Mumbai offers an opportunity to exhibit products, technologies and services to potential buyers and generate sales leads / order booking, networking with the industry/ establishing business contacts, launch new products, appoint agents and distributors, brand building, market research to gauge market trends.
