India Trade Promotion Organisation (ITPO) will be organizing the 43rd edition of India International Trade Fair (IITF), at Bharat Mandapam (New Delhi), from November 14-27, 2024.

Interested exhibitors will be required to complete the mandatory registration process through the portal. - B. ITPO will be opening **some smaller booths out of the unsold area in Hall No. 11 and 14 Ground Floor** for general bookings for all registered Private exhibitors from **11.00 am on 11th October, 2024 (Friday)** through online booking portal <https://domesticbooking.indiatradefair.com/>
- C. The list of booths and layouts of the said smaller booths will be published by **6.00 PM on October 10th, 2024** on the website <https://domesticbooking.indiatradefair.com/>
- D. In view of the above changes, **Online Bookings of IITF 2024 will be closed from 6.00 PM on October 10th, 2024 and will reopen at 11.00 AM on October 11th, 2024.**
