RULESANDREGULATIONSFORPARTICIPATION

- Policy for booking and allocation of Space Right for allocation of boothsreservedwithITPO.
 However, allotments hall be does not advance payment shall be deemed final for considering seniority.
- 2. ParticipationCharges:Per sqm chargesforShellScheme
 - a. Rs.22,500/-per sqm (Tentative) under MAI Scheme
 - b. Rs. 40,000/- per sqm (Tentative) under Non MAI scheme
- 3. <u>Tax Deduction at Source (TDS)</u>Applicants will have the option of deductingthe TDS by them. Such exhibitors are required to submit the TDS Certificatesoon after the TDS is paid to the Govt. In addition, participant will submit an Affidavit with respect to same.
- 4. <u>Approval Letter Approval letter for participation in the exhibition shall be sued after fulfilment of following conditions by the applicants: (i) Receipt of duly filed in application (ii) 100% payment towards participation (iii) Documents as specified.</u>
- 5. Cancellation and Refund of Application Money/Space Rent Requests forrefund of amount shall be processed under the rules, after the closure of the Event.(A) Full refund isallowedwhen:(a) Thereis a changein thevenue or date oftheevent byITPO and due to this the applicant is unable to participate. Refund of spacerent/applicationmoney,onaccountofcancellationbytheapplicantafterallotmentbyITPO,willbem adeasperthefollowingquidelines:
 - A. After allotment of booth, refund will be allowed only If the cancelled both is allotted by ITPO to other exhibitor as per following conditions.
 - a. Cancellationrequestmade45daysorlessbeforestartoftheevent(the start day will not be included), 100% application money depositedwillbeforfeited,irrespective ofthedateof allotmentofstall.
 - b. Cancellationrequestmadebetween 45 days and 90 days before the start of the event(the start day will not be included),50%oftheapplication money deposited will be forfeited, irrespective of the date of allotment of stall.
 - C. Cancellationrequestmade before 90 days of the start of the event(the start day will not be included),100 %oftheapplication money deposited will be refunded, irrespective of the date of allot mento fstall.
- 6. **Arbitration**All matters of dispute arising out of this shall byIndianlawandsubjecttoCourtjurisdictioninNewDelhi.Both the parties (i.e. ITPO and the applicant) shallmake all effort to resolve any dispute by way of reconciliation. In the event ofany doubt, dispute or difference arising out of the participation/application(except as to matters, the decision to which is specifically provided under thisTermsandConditionsdocument)remains unresolved, the sameshall bereferred to CMD, ITPO for appointment of Sole Arbitrator and the decisiongiven by Sole Arbitrator shall be binding on both the parties. The provisions ofIndian Arbitration & Conciliation Act 1996 shall also apply on both the parties. The venue of the arbitration proceeding shall be the Head Quarters of ITPO inNew Delhi. The fee payable to the Arbitrator shall be paid equally by both theparties.

7. Terms and conditions :-

- a. Dispute Regarding Quality Problems etc.: ITPO shall not be a party toanydisputesarisingout ofqualityproblems.
- b. IncaseITPOisputtoanylossforanyactofomissionand/orcommission of / by the participant, ITPO shall be made indemnified bysuchparticipant.
- c. Unauthorized Occupation of Space: Unauthorized occupation of anyspace- inside the hall

- including passages or outside the halls shallattract confiscation of exhibits and imposition of penalty, as deemed fitbyITPO.
- d. Deviation in Display Profile: The display of products other than thatmentionedintheirapplicationshall betreated unauthorized and may also attract penalty as deemed fit by ITPO.
- e. Stall Alteration: No alteration of the size or position of an exhibitor'sstallispermitted.ITPO,however,reservestherighttomodifythelayoutsofstallsites andgangways.
- f. Passage: Participants may ensure that their exhibits must not obstructpassages. Public passages and gangways should be left clear. Nohindrances, protrusion of exhibits shall be permitted. Noncomplianceshallattract penalty.
- g. Temporary Staff: ITPO shall not be responsible for any dispute arisingoutofhiringofservicesofcasualworkers/hostessesbytheparticipants.
- h. Attendance at the stand: No stand should be left unattended during the exhibition hours. The participants will not carry out any activity, which inthe opinion of ITPO amounts to nuisance or annoyance. ITPO shallhavetherightto takeremedial actionasdeemedfit, insuchcases.
- i. Submission of application for booking of space does not automaticallyconfer a right for allotment of space. Approval of application for spacewillrestwith ITPO.
- j. ThespaceallottedtotheapprovedparticipantsistobeexclusivelyusedbythemforSale/Displayofthe irexhibitsasapprovedbyITPO.Subletting of space is not allowed. Violation of this clause maylead to cancellation of space allotted, forfeiting of space rentpaidtoITPOanddebarringtheparticipationfromthefutureparticipation in ITPO'sevents.

8. Visa:

- a) A Notarized Affidavit (executed on a stamp paper of Rs.50/-) as perAnnexure-IllisrequiredbeforeissuingVisaRecommendatoryletter.
- ITPO,asaTradePromotionOrganisation,willprovidenecessaryassistancetotherepresentatives
 oftheparticipatingCompanybyissuing recommendatory letter to the concerned Mission for
 obtainingvisa.
- C) Visa recommendation letter will be issued only in favour of the ChiefExecutive /Proprietor/Senior Level Officer dealing with exports of theCompanywho can takeonthe spot decision.
- d) ITPOshallnotbeliable,incasetheconcernedMissionofthehost/transit country denies visa to a representative of the participatingCompanyfor anyreason.
- e) SinceITPO,onbehalfoftheparticipatingcompany,hasalreadycommittedforcertainfinancialbindi ngsbybookingofspace,construction/decorationofstand,catalogueentry,generalpublicitysuppo rt etc.,it will notbe possibleto consider any refund on accountofdenial of visa/delayin receiptofvisa.
- f) The representative would come back to India after the Event/Fair isover and would submit the proof of his/her departure/arrival, wherevernecessary.
- g) Applicantisrequestedto applyforvisawellintime.

9. General:

- a. Only goods of Indian origin will be allowed for display in Indian Pavilion.Participants will be allowed to display only those products which havebeen selected and approved by ITPO.
- b. Participants will make their own arrangements for removing exhibitsfrom the packing cases and displaying them in the booth.Likewise,after the Fair, participants will make their own arrangements to repackandsendthe exhibitsback to India.
- C. Participants will not be allowed to remove the exhibits during the showwithoutspecificwrittenpermissionfrom ITPOorShowOrganisers.
- d. Being MAI event, participants will be required to furnish complete information on ordersbooked, enquiries generated, retails ales, etc.during andafter theclose Show.Compliance with this the criteriaforselectionof rule will be one of theparticipantsforfuture ITPOprogrammes.
- e. All expenses for travel to &fro, and stay abroad including

- boarding,lodging,medicaltreatment,insurance,etc.willbebornebytheparticipantsthemselves.T heparticipantsshouldarrangesufficientfundstomeet sucheventualities.
- f. Participants will adhere to such other regulations as may be prescribedbythecountryinwhich theshowis heldand/or theFairOrganisers.
- g. In the event of postponement/abandonment/cancellation of the Fair/Exhibition/Show, or in case of exhibits not being displayed due to anyreason,ITPO shall be under no liability to compensate expenditure or loss, if any, incurred by the participants.
- h. In case of default of any payment due from the participants, ITPOreserves the right to debar them from participation in ITPO's Fair inIndia&abroadandbringtothenoticeofappropriateauthority.
- i. ITPO shall not be responsible for any loss of business / property arisingout of the participation in the event.No action for indemnification shalllieagainst ITPO.
