All private exhibitors of the upcoming India International Trade Fair (IITF), to be held from November 14-27, 2024, are hereby advised to follow the instructions mentioned below in respect of their participation:

1. The possession of space / booth for Online Private Participants of IITF 2024 will be provided as per the table below: -

Bare Space in All Halls (for construction)	After 12 Noon on November 06, 2024
Shell Scheme in All Halls	After 10 AM on November 11, 2024

- 2. Electricity of 0.5 KW per 12 sqm is included in space rentals. Participants who require additional electricity or water connection may purchase the same through ITPO's online portal <a href="https://domesticbooking.indiatradefair.com/">https://domesticbooking.indiatradefair.com/</a> under the "Buy Services" Tab on the left-hand menu bar. Payment for these additional services is to be made online.
- 3. Service badges for Labour Movement and Entry Slips can be collected after 11 AM on 6th November, 2024 from the Multipurpose Hall on the Ground floor of ITPO Admin Building at Gate no. 9, Bharat Mandapam (on Mathura Road, near Supreme Court Metro Station)
- 4. **Service badges** for workers, fabricators etc. can be obtained on submission of the following documents:
  - i. **Authorization letter on the exhibiting company's letterhead** in favour of the service provider(Fabrication agency, etc.) in case of self-construction of the stall by exhibitors.
  - ii. Letter from the fabrication agency on letterhead with the list of Names, Aadhaar Number/ Govt. ID Number of all the workers along with recent photograph and copy of Aadhaar.
- 5. Exhibitor Kits, including Exhibitor Badges, Car Parking Passes can be collected after 11 am on 11th November, 2024 from the Multipurpose Hall on the Ground floor of ITPO Admin Building at Gate no. 9, Bharat Mandapam, as per the details mentioned below:-
