## **NOTICE**

India Trade Promotion Organisation (ITPO) will be organizing the 43<sup>rd</sup> edition of India International Trade Fair (IITF), at Bharat Mandapam (New Delhi), from November 14-27, 2024.

- A. The booking of select booths at premium rentals by private companies for participation the exhibition will be through ITPO's online booking portal in https://domesticbooking.indiatradefair.com/. Interested exhibitors will be required to complete the mandatory registration process through the portal. The link for online registration will be available on ITPO's corporate website. https://www.indiatradefair.com/ the micro-site of IITF 2024. i.e. https://indiatradefair.com/iitf/ and the online booking space portal https://domesticbooking.indiatradefair.com/
- B. ITPO will be opening the second stage of booking for Premium Booths for registered Private exhibitors from **11.00 am to 5.00 pm** on **23<sup>rd</sup> September 2024 (Monday)** through online booking portal <u>https://domesticbooking.indiatradefair.com/</u>
- C. The booths will be available at a premium over and above the regular rentals. The rentals for this phase of booking by eligible Marquee Companies will be at a rate of Rs. 27,000 per sqm.(shell scheme), and Rs. 26,500 (bare scheme) exclusive of GST. Extra Corner charges will also be applicable as given below:

No. of Sides Open	Extra Corner Premium on Space Rentals
2 side Open	10%
3 side Open	15%
4 side Open (Island Type)	20%

D. The mapping of booths / halls will be based on product profile. Applicants will be able to book a booth in the hall earmarked for the product category selected by them at the time of registration for IITF 2024. The mapping of category and halls is mentioned in the table below:
