Products for display include diamonds, fine jewellery, silver jewellery, pearls, titanium jewellery, fashion jewellery and accessories, watches, clocks & accessories, writing instruments display/packaging, equipment & tool supplies & services etc.South Africa's imports on jewellery was to the tune of US\$ 907 million in 2013 and main articles of imports include diamonds, articles of jewellery, imitation jewellery, precious and semi-precious stones. India's exports to South Africa amounted to US\$ 72 million accounting for around 8% of total imports of jewellery by South Africa.

Africa, being a focus country identified by DoC for Export promotion, the event has received grant from the Government and is heavily subsidized. Participation charges for the fair would be approximately Rs.75,000/- for a booth of 9 sq.mtrs. which would include necessary furniture, lighting and display aids. Additional space would be available in multiples of 9 sq. mtrs. An additional 10 % would be charged for corner booths and will be allocated on first-cum-first-served basis. Any additional display aids required by the participants can be procured from the Contractor on direct payment.

The import duties into South Africa from countries, other than EU, is 20%. There is also a 14% VAT implication on imported jewellery. In terms of temporary imports for fairs, companies usually utilise the ATA Carnet system in which there are no import duties or VAT applicable.

There will be a 24-hour armed security contingent provided by the Fair Authorities for the duration of the Fair. A limited number of safes are available for hire for the duration of the Fair on a first-come-first-served basis. The cost of hiring a safe includes delivery and collection. Participants may hire safes for their exhibits, if required, by paying directly to the Contractor. Participating companies would be responsible for all their insurance requirements and must ensure they have adequate cover for all exhibits, display material and public liability.

We are sure you would like to avail the opportunity to explore and increase exports to the region by participating in Jewellex Africa. For confirming participation in the show, please send us the filled in application form along with advance participation charges by demand draft of Rs. 40,000/- in favour of India Trade Promotion Organisation payable to New Delhi.
