1.	BTW India Pvt. Ltd.	MSME Exemption: Please confirm if MSME registration holders are exempt from paying Earnest Money Deposit (EMD) and Tender Fees.	Tender Fee and EMD are exempted for MSMEs. Bidder shall submit valid MSME certificate along with the bid.
2.	BTW India Pvt. Ltd.	IGL Gas Pressure: Could you provide information on resolving the low gas pressure issue?	Different gas pressure is available at different cooking locations. Currently, the gas connection at Mezzanine is 2 bar and at Horseshoe is 300 millibar.
3.	BTW India Pvt. Ltd.	ITPO will remove, reinstall Horseshoes Glasses and Exhaust	Upon request ITPO would remove up to 5 glass panes for serving food from Horseshoe.
4.	BTW India Pvt. Ltd.	Grant Sign Board Permission hang on own stall on Horseshoes and 1(a) & 1(b)	Basic signages will be provided by ITPO. For additional signages, the vendor should not take support from structures and the nearby structures should not be damaged.
5.	BTW India Pvt. Ltd.	Cluster A Food Court Connections: Please confirm availability of GAS, Water, Water Drainage and Electricity connections for Food Court 1(a) & 1(b) & Horseshoes.	In Cluster A: Single point connections of gas, water, drainage and electricity will be provided in Horseshoes which may be distributed by the vendor at their own cost as per their requirement. Only electricity will be provided in Food Court 1(a) & 1(b).

6.	BTW India Pvt. Ltd.	Cluster B Food Court Connections: Similarly, confirm availability of GAS, Water, Water Drainage and Electricity connections for Food Court and cooking area.	For Cluster B: Gas, water, water drainage, and electricity connections will be made available to the vendor.
7.	Nesco Foods	Cluster A – 5 Horseshoe we would suggest if we could open window and service food from window. For which exhaust system should be appropriate and would need standing table space as well.	Upon request ITPO would remove up to 5 glass panes for serving food from Horseshoe provided the vendor would ensure that the fire tender path remains clear without any furniture. Standing tables maybe placed by the vendor at the nearby green area.
8.	Nesco Foods	Mezzanine Floor on Hall 2-4-5. Would require high pressure in PNG line, proper drainage system as well as lift services – movement of food and raw materials.	Appropriate pressure is available in PNG lines and proper drainage systems; multiple service lifts are available for food/raw material movement.
9.	Nesco Foods	Cluster H: Mezzanine floor – as restaurant could be considered to make into a food court being a B2C show it would be better in food court style of options rather than fine dining form.	As per RFP, no change.
