CORRIGENDUM-2

It is informed that due to administrative reasons, the following changes have been made in the Tender Ref. No. ITPO/F&B/TA-I/IITF/2023 dated 30.9.2023:

I. Clause No. 3: “AREA/LOCATION PROPOSED TO BE LICENSED” on Page 3

Note:-

- (i) The proposed temporary license covers only the area as indicated above and as shown in the enclosed drawing with detailed specifications indicated thereon and no other area within Pragati Maidan, New Delhi. The Licensee(s) shall use the said Licensed Premises only for the purpose of operating F&B outlets subject to the terms and conditions and the guidelines and policies framed by Licensor from time to time, and for no other purpose (hereinafter referred to as “Permitted Purpose”). Apart from licensed premises, no other area inside Pragati Maidan, New Delhi shall be used by the Licensee(s). No food/ beverage are to be served in any manner anywhere outside the designated licensed area.

- (ii) As part of allotment of temporary F&B locations during IITF 2023 scheduled to be organized from 14-27 November 2023, ITPO is publishing six tenders simultaneously for allotment of all the available food outlet locations and the vending points as per respective locations notified in the different tenders; details as mentioned under:

(iii) All the bidders will be eligible to bid for all the locations in the six tenders being published simultaneously by ITPO. However, out of the six F&B locations viz. Food Court -1 (FC-1), Food Court-2 (FC-2), Food Court -3 (FC-3), Food Court -4(FC-4), Kiosk K-11 and Kiosk K-12, one bidder will be considered for allotment of maximum of two locations on highest (H1) bid basis.

(iv) The bidder considered for any of the two locations on H1 bid basis will also be eligible to be considered for allotment of (i) 14 nos. Vending Points and (ii) Mezzanine Floor at Hall 14 (for buffet service providing make-shift restaurant operations) on H1 bid basis.

(v) Any bidder considered for allotment of two locations (out of FC-1, FC-2, FC-3, FC-4, Kiosk K-11 and Kiosk K-12) and / or Mezzanine Floor of Hall 14 and / or Vending Points will be liable to take possession of all the locations for which it has been selected as the H1 bidder failing which all allotments during IITF 2023 of the said bidder will be considered for cancellation and the bidder will be considered for debarment as per the applicable rules/guidelines. **In-case a bidder is found to be H1 bidder for more than two locations out of the six locations mentioned at Para 3(iii) above, in that case, preference of allotment of the locations on H1 bid basis will be at the discretion of ITPO subject to maximization of ITPO's revenue.**

IV. Addendum to Clause No. 12 “OTHER TERMS & CONDITIONS” at Page 13

Negotiations, if at all, shall be an exception and/or only in the case when one bidder becomes H1 for more than two locations (out of the six prescribed locations for which a bidder can be considered for a maximum of only two locations) as per conditions of the RFP. Counter offers tantamount to negotiations, shall be treated at par with negotiations.
