Subject: Filling up of the post General Manager (Works) in ITPO on immediate absorption basis, or on deputation basis initially for a period of three years.

The India Trade Promotion Organisation (ITPO) is a Government of India Enterprise under the Administrative Control of Ministry of Commerce & Industry. ITPO has undertaken an ambitious re-development plan of Pragati Maidan and is constructing an Exhibition-cum-Convention Centre at an estimated cost of Rs.2700 crore (approx.). The process has already commenced and the construction work is in full swing.

2. In view of urgent requirements, ITPO invites applications for filling up <u>one</u> **post** of General Manager (Works) in the in the pay-scale of ₹100000-260000 (IDA) for both; on immediate absorption basis, or on deputation basis initially for a period of three years. However, ITPO does not provide residential accommodation to the incumbent. Perks and Allowances as applicable to IDA Pay scales will not be applicable to the incumbents whose parent cadre scale is CDA scale. Perks and allowances, whose parent cadre scale is in CDA pattern, will be admissible as per DPE/DoPT guidelines.

3. The General Manager (Works) will be head of the Division which comprises Civil Engineering, Electrical Engineering, Audio-Visual Unit, Architectural Unit and Conservancy arrangements. General Manager (Works) has to provide leadership to meet the needs of ITPO that include maintenance of Pragati Maidan and Exhibition halls and providing engineering services/facilities in the trade fairs and other events to the participants and third party organizers.
