- 3. The basic criteria for selection of artiste(s)/ troupe(s) are:
 - a) The artiste(s) should be currently empanelled with Sangeet Natak Academy or Indian Council for Cultural Relations (ICCR) and should have rendered public performance at least on two occasions (supported by proof such as newspaper clippings, photographs, video recordings etc.) in the last three years.
 - b) National award winners and performers at international and major national events shall be given weight age in this order.
 - c) Artistes who have performed in three consecutive IITFs are not eligible to apply.
- 4. The applications of the eligible artistes will be assessed by a designated Cultural Committee constituted by CMD, ITPO. In addition to individual applications. The Committee will also consider nominations received from Sangeet Natak Academy, ICCR, National School of Drama and similar organisations on ITPO's request. The committee after considering applications and nominations will recommend a merit list of artistes/ troupes for each of the categories. On acceptance of the list by ITPO, vacancies shall be filled from the list accordingly.
 - 5. The interested artistes fulfilling the eligibility criteria as mentioned above are requested to send their applications for the respective category(ies) to Manager (Culture), India Trade Promotion Organisation, Pragati Maidan, New Delhi 110 001. The applications must be sent in the prescribed format attached herewith. The last date for submission of application is 31st August 2016.
