

Subject : Licensing Guidelines of Exhibition Space and Facilities in respect of Third Party Events at Pragati Maidan.

The following guidelines are issued with immediate effect:-



- (i) The team required to inspect the compliance of licensing guidelines/norms in respect of third party events will be headed by a Senior Manager level officer in BDD Division with Manager/Deputy Manager level officers to be drawn from Architect, Security/Fire and F&B Divisions/Units. The recommendations/decisions will be jointly made by the Inspection Team. The Inspection Team will make visits in a manner that the third party organizers are first made aware of the deviations and requested to remove the deviations and then only penalty imposed for deviations, if any, persisting.
 - (ii) The commonly noticed deviations have since been identified and are detailed in the two proformas enclosed for inspections pre and during the event/exhibition indicating the nature of deviations and the penalties for such deviations. Such deviations and the penalties to be imposed will be made known to third party organizers upfront and also during the visits to be made by the Inspection team.
2. ITPO's licensing guidelines of exhibition space and facilities at Pragati Maidan as updated from time to time will stand modified to the extent indicated in para 1 above.
 3. All the officers/staff are requested to comply with these guidelines and any non-compliance thereof will be viewed very seriously.
 4. This issues with the approval of CMD, ITPO.
