Subject: Ministry of Ayush proposal - Request for exemption from Model Code of Conduct for International Day of Yoga activities - reg.

Sir/Madam,
I am directed to refer to Ministry of Ayush letter No.M-16011/3/2024-YN, dated March 26, 2024, on the subject cited and to state that the Commission has no objection from MCC angle, to the request made therein subject to the condition that in respect of events/activities during the period of Model Code of Conduct, the following must be strictly adhered to:

1. Photos of any Minister/Political functionaries should not be displayed in the events in the Constituencies/districts where MCC is in force.
- 2.No political functionary should be invited during the event in the Constituencies/districts where MCC is in force.
3. The invitees participating in all the events must observe all conditions of MCC.
- 4.If any advt. is to be issued in this regard, it shall not have the photographs of any Minister/political functionaries in the newspapers having edition or circulation in the Constituencies/districts where MCC is in force.
