7. SELECTION PROCESS

- (i) The objective type paper based (OMR Sheet) written examination will be conducted by ITPO. The selection of the candidates will be based on:
 - a. The fulfilment of the prescribed eligibility criteria.
 - b. The final scores obtained in the respective UPSC Examinations, 2023 i.e. Civil Services (Main) Examination, 2023, Engineering Services (Main) Examination, 2023, and the Central Armed Police Forces (ACs) Examination, 2023 (including the Written and Personality Tests) of the candidates who were not finally recommended for appointment and have opted to disclose their details under the Disclosure Scheme.
 - c. The marks secured by the candidates in the objective type paper based (OMR Sheet) written examination conducted by ITPO.
- (i) The bilingual (English and Hindi) objective type paper based (OMR Sheet) written examination will be as per the structure outlined below:

- (ii) Information regarding date and venue of the examination center will be communicated by ITPO in due course. The written examination will be followed by personal interaction/document verification of the candidates. Further details in this regard will be intimated to the shortlisted candidates by e-mail and also through the Admit Card.
- (iii)A total of 100 marks has been allocated for the final merit for selection. The marks will be determined based on the following criteria, and the merit will be determined accordingly:

d)	Wherever two or more candidates have secured equal aggregate marks on the above criteria, the tie(s) will be resolved as outlined in the next column.	A. For eligible candidates having Civil Services Examination, 2023 score for the post of Deputy Manager (General Cadre), Deputy Manager (Law), Deputy Manager (Finance & Accounts): (i) Candidate securing more marks in the @Compulsory Papers and the Personality Test conducted by UPSC put together is to be ranked higher; and (ii) In case where the marks mentioned at (i) above are equal, the candidate senior in age is to be ranked higher. @ Compulsory Papers include Essay, General Studies-I, General Studies-II, General Studies-III and General Studies-IV. (i) Candidate senior in age is ranked higher;
(ii) If age of candidates is same, the candidate getting
more marks in the written total is ranked higher;
(iii)If the marks in the written total are equal, the
candidate getting more marks in Paper-I (General
Ability & Intelligence) is ranked higher.
