ITPO has introduced an Annual Medical Examination Scheme for Group 'A' officers aged 40 years and above (covering both regular ITPO employees and those on deputation), in alignment with DoPT Office Memorandum No. 210/11/1/2009-Estt(A)-Part dated 01/02/2012. The detailed list of medical tests to be conducted under this scheme is attached at Annexure-I.
