Ι.	Incorporated as a private limited company (as defined in the Companies Act, 2013) or a limited company/bank.	
II.	The company/bank must neither be a foreign company nor subsidiary of any foreign company.	
III.	The company/bank should not be formed by splitting up or reconstructing any existing business/company.	
IV.	The FinTech company/bank should have relevant similar experience of digital transaction business at least during the last five years ending the last date of submission of bids.	
V.	The average annual turnover of the company/bank should be over Rs. 100 crores in the last five financial years ending 31 <sup>st</sup> March 2022 from the digital transaction business.	
VI.	The company / bank should not have been debarred / black-listed by any Central Govt., State Govt. Public Sector Undertakings of the Central Government and State Government or RBI or any other regulatory authority or Financial Institutions in India as on date of EOI submission.	
VII.	The service provider should ensure that there are no legal proceedings / inquiries / investigations have been commenced / pending / threatened against service provider by any statutory or regulatory or investigative agencies or any other for which performance under the contract will get adversely affected / may get affected.
