#### 3. Terms & Conditions:

- i Sealed quotation along with attested copies of PAN & GST certificates shall be deposited with "Manager (Stores), Room No.129, India Trade Promotion Organisation, Hall No.12, Near Gate No.10, Pragati Maidan, New Delhi-110001" before due date and time. Late bids cannot be considered. The tender reference number and date plus "Subject of Bid" should be mentioned on top-left corner of envelope. Quotation must be submitted in an organized and structured manner. No brochures/leaflets etc. should be submitted in loose form.
- ii. Bid documents should be submitted with Index page and page numbers (including technical literature). Each page of the bid should be signed & stamped in original.
- iii. Fax/E-mail/Telegraphic/Telex tenders will not be considered unless it is asked for.

- iv. **Opening of bid**: The quotations should reach ITPO's Office on or before 08/09/2020 at 3.00 p.m, which will be opened on the same day at 3.30 p.m. by Purchase Committee in the presence of intending quotationer/their authorized representative(s).No camera /mobiles are allowed during tender opening.
- v. The bidder shall have an experience for at least two years in the field of supply of Official Storage Device item to any state/central Govt. Departments/PSUs. Self-attested Copies of supply order should be submitted along with the tender.
- vi. The rates must be quoted in Indian Rupees only for the reputed brand/make and should be clear in all respect.
- vii. The rates quoted for all the branded item(s) should not be more than MRP in any case.
- viii. The GST Number as well as PAN No. of ITPO is **07AAATI2955C1ZX** and **AAATI2955C**, which will be required to incorporate on the face of bill by Successful Bidder.
- ix. Quotations must be free from correction & erasers and would be valid for a minimum period of 120 days from the date of opening of the sealed quotation.
- x. All prices quoted must be firm and no revision in the price quoted will be allowed after tenders are opened. Incomplete Tender/Hypothetical Tender/Conditional Tender could not be accepted.
- xi. Price quoted should be inclusive of freight, packing, labour, and other incidental charges. Applicable GST will be paid extra, which should be clearly specified in the quotation.
- xii. India Trade Promotion Organisation reserves the right to accept or reject or withdraw any quotation in part or full without assigning any reason whatsoever and no compensation will not be for the same. India Trade Promotion Organisation also reserves its right not to accept the lowest rates quoted by the quotationer.
- xiii. **Delivery:** The selected bidder must deliver the goods ordered within one month from thedate of placing supply orderat Stores Division, Room Number-129, Near Hall Number-12, ITPO, PragatiMaidan, New Delhi-110001.
- xiv. **Payment:** The payment of successful bidder will be released after complete and satisfactory supply of indents to ITPO. The payment will be processed after submission of Bill/Invoice, delivery challan, Bank details and cancelled cheque, warranty/quaranty card and other desired documents.
- xv. **Penalty:** If the selected seller fails to deliver any or all the goods within the original/re-fixed delivery period(s) specified as per terms & conditions, ITPO will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions, @ 0.5% per week or part of the week of delayed period as pre-estimated damages not exceeding 10% on the Tender Cost without any controversy/dispute of any sort whatsoever.
- xvi. EMD/Bid Security-Sealed Quotation completed in all respect may be dropped in the drop box (kept in Stores Division of ITPO at Hall No.12) along with DD of Rs.1600/- (Rupees One thousand six hundred only) towards EMD charges, drawn on any of the Scheduled Commercial Banks in favour of India Trade Promotion Organisation, New Delhi.

# xviii. **EMD/Bid Security**

The EMD of successful bidder will rest with ITPO till the completion of contract and the EMD of unsuccessful bidder, without levying any interest, will be liable to refund within 30 days after placing final order to the successful firm(s).

- xix. The EMD shall stand forfeited, if a bidder withdraws or amends the quotation/ tender, or impairs or derogates from the tender in any respect during the bid period, or in case successful bidder fails to sign or accept the <u>contract</u> within the stipulated period. No interest will be payable on this amount. The EMD shall also stand forfeited in the event of premature withdrawal of the tender / quotation by any of the tenderers.
- xx. In order to identify uniformity and quick assessment of the rates, the rates should be mentioned as per unit(s)/quantity/items and brands/specifications, as per the Description of Items mentioned in the **Schedule of Requirement(SoR)**, the intending firms should not make any deviation and quote rates for all the units, quantity, brands. Otherwise such bids shall be rejected.
- xxi. The bidders should be Delhi-NCR based only, whose office operating in oraround Delhi. Under no circumstances, the agency, outskirt of Delhi-NCR could be considered.
- xxii. The successful bidder, on award of contract/order, must send the "Letter of Acceptance" (LoA) in writing, within 07 days after placing of award of contract/order failing which the EMD will be forfeited.

## xxiii. Corrupt or Fraudulent Practices

ITPO requires that the bidders who wish to bid for this tendered item have highest standards of ethics. ITPO will reject a bid if it determines that the Bidder recommended for award has engaged in corrupt or fraudulent practices while competing for this contract. ITPO may declare a vendor ineligible, either indefinitely or for a stated duration, to be awarded a contract if it at any time determines that the vendor has engaged in corrupt and fraudulent practices during the execution of contract.
