Terms & Conditions

- 1. The stitching of uniforms should be technically good and of acceptable standard and sub-Standard will not be accepted.
- 2. In case of any complaint in stitching the full cost of cloth will be recovered from the vendor.
- 3. All adjustment required in the uniform to the satisfaction of the individual security staff would be made by you free of cost.
- 4. The stitching work should be completed within 30 days from the date of issue of the works order or after collecting the uniform cloth from the Store Division, ITPO.
- 5. Please note that unnecessary delay in stitching work will not be acceptable. In case of delay 25% will be deducted from the total amount of the bill.

- 6. The bill in triplicate duly pre-receipted will be submitted to this office after satisfactory completion of work.
- 7. The reference number of this notice shall be mentioned on the sealed envelope under which the quotation is being sent.
- 8. The tailor will stitch the uniform to the satisfaction of an individual. If during trial an individual is not satisfied with the stitching, the tailor will provide the good fitting uniform at his cost.
- 9. The specification of stitching material should be as under:
 - (a) ZIP YKK
 - (b) Thread- Three ply
 - (c) Button Nylon
- 10. **Security Deposit**: A Demand Draft in favour of India Trade promotion Organisation Pragati Maidan New Delhi is to be deposited @ 3% as security deposit.
- 11. **Measurement**: The measurement of the security personnel will be taken in three working days.

Arbitration

In case of any dispute, both the parties shall make all efforts to resolve by way of conciliation process. In the event any doubt, dispute or difference arising out of or in relation to the Contract remains unresolved, both the parties to the Contract will mutually appoint a Sole Arbitrator, in accordance with the Arbitration and Conciliation Act, 1996.

Jurisdiction

All disputes arising out of and in relation to the contract between the parties herein shall be governed by Laws of India subject to the exclusive jurisdiction of the courts of Delhi only.
