- **3.** Bids are invited in two-bid system i.e. Technical Bid and Financial Bid. The tender shall be submitted online in two envelopes. The technical bid envelope shall contain the following:
 - a) Company Details and Manufacturer Authorization Form (MAF) issued by OEM authorizing the reseller to supply the work items to ITPO as per tender under consideration.
 - b) Documents as per Annexure-1 to Annexure-8.
- **4.** Financial Bids shall be submitted as per `Item Rate BoQ`.
- **5.** Tenders without Earnest Money Deposit (EMD) and Tender Fee shall be summarily rejected. The EMD of unsuccessful bidders shall be refunded after award of work to the successful bidder.

Note: The firms registered with National Small Industries Corporation (NSIC)/Micro, Small and Medium Enterprises (MSME) are exempted from furnishing EMD and Tender Fee provided that such small scale units are registered under single point registration scheme of NSIC / MSME and are valid on the scheduled date of tender opening and the product range mentioned in the certificate is the same or similar to the tender requirement. 6. Incomplete/ conditional bids shall not be considered.

- **8.** The timelines mentioned in the tender document should be strictly adhered to. - **10.** If any bidder withdraws its bid during the bid validity period to intend to make any modifications in its offer or the tender terms & conditions, then ITPO without prejudice to any other right or remedy, be at the liberty to forfeit the EMD absolutely or blacklist the firm.
- 11. Settlement of disputes, if any, shall be as per the Arbitration and Conciliation Act, 1966 by an arbitrator to be appointed by Chairman & Managing Director (CMD), ITPO.
- **12.** Disputes, if any arising out of this contract shall have exclusive jurisdiction of Courts in Delhi only.
- **13.** It will be the responsibility of the successful bidder to comply with all the statutory obligations on its part arising out of this contract.
- **14.** The payment to the agency shall be released after the successful delivery of all the work items and verification of the license period/warranty to the satisfaction of ITPO. The successful bidder will be mandatorily required to get the license period of the work items verified from the OEM through formal certification via email/letter/web-based portal authentication.
