**5.** <u>Validity of Bid:</u> The bid shall be valid for 120 days from its finalisation/award of work. No variation in approved rates would be considered in any circumstances.

- **6. Opening of Bid :** The Bids will be opened on 03/01/2024 at 3.00 p.m. After the online opening of the Technical Bid, the results thereof shall be intimated to the bidder.

#### 9. The Bid shall be submitted only online and in two parts, namely:-

- (a) Technical Bid
- (b) Financial Bid

#### (a) Technical Bid:

The bidder should read and ensure the provisions laid down under technical eligibility criteria and submit/upload the requisite self-attested scanned documents as has been asked in technical eligibility criteria. Please refer the provisions of technical eligibility criteria (check list).

#### (b) Price/Financial Bid:

- (i) Schedule of Price Bid in the form of BOQ XXXX.xls.
- (ii) Scanned copy of Price Bid undertaking (Annexure IV)

#### 10. SCOPE OF THE WORK

- (i) ITPO needs 10 to 25 Golf Carts to be engaged during the India International Trade Fair and other events to be held at Pragati Maidan, New Delhi and/ or later if the need arises and visit to Bharat Mandpam for booking and other purposes etc.
- (ii) The Golf Carts shall be initially deployed during currency of the IITFs and other events at Pragati Maidan or as per requirement /need of the ITPO. The requirement of Golf Carts may be increased or decreased at any time.

#### 11. <u>Technical Eligibility Criteria</u>

- (i) The registered business office of bidding firm/agency (i.e. the bidder) should be located in Delhi/Delhi NCR Region. The bidder is required to upload the proof of office address along with telephone number during the online bid submission. In case, the firm/agency located outside of Delhi or Delhi NCR Region, their online bid application should be summarily rejected.
- (ii) "Legal Status" The Bidder should be either a Proprietorship /Partnership/ Firm Public or Private Ltd Company or a Government approved contractor operator within India. Relevant papers,

such as, copies of original Registrations documents defining constitution of the Applicant or legal status or Certificate of Incorporation/ Memorandum/ Articles of Association partnership deeds etc to be provided as a supporting document in case of Co.

- (iii) The Golf Carts should be in excellent condition and should not be more than 2 to 3 years old. The Firm/Agency should submit a "Declaration" on its own letter head in this regard.
- (iv) The bidder should be registered under GST and necessary certificate may be provided as a supporting document.
- (v) The bidder should have completed/undergoing (one year successfully completed in case of undergoing work) one similar work of volume not less than Rs.10 lakh in last 5 years from Govt./ Semi Govt./ PSU / other Govt. Bodies. In case of private/corporate company, the bidder will also submit TDS in support of the minimum 3 work orders.
- (vi) The Firm/Agency should submit balance sheet and profit loss account for the last three years duly audited by certified Chartered Accountant (CA).
- (vii) The Firm/Agency should submit last three years IT Return.
- (viii) The Bidder shall provide the Registration Number (UAN) of each and every employee who will be deployed in ITPO.
- (ix) The permanent employees on the rolls of the bidder including at least two employees having Technical knowledge for executing the similar job/ experience of 2 years should be available to deal the matter.
- (x) The participant bidder must submit towards **Earnest Money Deposit(EMD) amount is Rs.56000/- (As EMD)** in favour of "India Trade Promotion Organisation" New Delhi through online/Demand Draft payable at Delhi. However, registered MSME/StartUP vendors shall be exempted from EMD and tender fees.
- (xi) The tender fee of Rs.2000/- (including GST) once remitted, is non-refundable and non-adjustable.
- (xii) The bidder should have valid registration under EPF & MP Act, 1952 and ESI Act, 1948. Copies of valid registration ESI and EPF Certificates are duly certified by authorized signatory.
- (xiii) The operator shall be responsible for providing Golf Carts and Drivers. The deployed driver should hold a valid driving license, police verification, in addition to Identity Golf Carts provided by the Operator /Contractor. The deployed driver needs to be permanent employee with the Golf Carts operator with a minimum of one year experience of driving Golf Carts. The driver shall also Golf Carts in original the valid, Pollution under Control Certificate, Vehicle Insurance, Registration Certificate of the vehicle. The driver will have to be provided with a working mobile phone at the cost of the contractor. In case the driver reports for duty later than 15 minutes before the schedule time, a penalty of Rs.200/- shall be levied and for every hour on each day of delay, a penalty of Rs.300/-, which will be levied and shall be deducted from the bills.
- (xiv) The agency should submit self-attested whole tender documents, which will prove in terms of "token of acceptance" towards terms and conditions laid down in bid document.
- (xv) The Agency/Firm, those who are not submitted requisite documents, so asked from (i) to (xiv) above, their candidature//bid will not be considered.

#### **GENERAL TERMS & CONDITIONS**

- 1. "Applicable Law" means all relevant laws in force and effect as of date hereof and which may be promulgated or brought into force and effect hereinafter in India, including judgments, decrees, injunctions, writs or orders of court, as may be in force and effect during the subsistence of this Tender Document.
- 2. "Bid Document" shall mean the document submitted by the bidder, pursuant to understanding and agreeing with the terms and conditions set out in this Tender Document.

- 3. The contracting party whether it will be a Proprietor/Individual, Partnership Firm, company/Corporation, Society, they shall be, for the purpose of this contract, be known as "the Bidder" and the India Trade Promotion Organisation shall be known as "ITPO".
- 4. "ITPO" means India Trade Promotion Organisation, ITPO requires the services of reputed, well established and financially sound firm/agency providing Low Floor Battery Operated Golf Carts, mentioned at Price Bid (Schedule of Price/Activities). The tenderer should have sufficient pool of men/machine to cater to the needs.
- 5. Address: For all purpose of the contract, including arbitration there under the address of the firm mentioned in the tender shall be final unless the contractor notifies a change of address by as separate letter sent by registered post with acknowledge due to the ITPO. The firm shall be solely responsible for the consequence of any omission or error to notify change of address in the aforesaid manner.

#### 12. Tender Evaluation Committee

- (i) ITPO will constitute the tender Evaluation Committee. The Committee shall evaluate the bid documents submitted by the bidder as per the Technical bid
- (ii) The Technical Evaluation Committee may choose to conduct technical negotiation or discussion with any or all the bidders. The decision of the Evaluation Committee in the evaluation of the Technical Bid and Commercial Bid shall be final and binding on all the parties/Bidders.

#### 13. <u>Undertaking</u>

- (i) An Undertaking from the Bidder stating the compliance with all the conditions of the Contract and Technical specifications of the Bidding document will be required and since no deviation will be acceptable to ITPO.
- (ii) The Bidder should give an undertaking that they are fully in compliance with the existing labour laws.
- (iii) Prices quoted will be excluding GST. GST as applicable will be paid separately. The tenderer shall submit documentary evidence of depositing the GST to the authority concerned
- (iv) Only online tenders received as per NIT will be considered. Tenders received through any other modes like FAX, and email, shall not be considered. The tenders received after due time and date shall not be considered and shall not be opened.

#### 14. <u>Instructions to Bidder:</u>

- (i) The deployed drivers/staff are hail & healthy and not suffering from any communicable diseases.
- (ii) In case the operator is not in a position to provide the required Golf Carts, on any day as per the schedule date and time, ITPO shall make alternate arrangement by hiring Golf Cart(s) and excess amount if any paid by ITPO, same shall be recovered from the pending bills/Security Deposit.
- (iii) In case No Golf Cart is provided by the operator, the Performance Guarantee will be forfeited and the Bid Applicant will be blacklisted by ITPO.
- (iv) Golf Carts along with the Driver will report at the place of duty/ supervisory officials of General Section, ITPO/ or to the officers concerned as the case may be, at the start of the duty on each day.
- (v) In case the deployment of the Golf Cart is extended beyond 12 hrs. as per requirement of ITPO, pro rata cost will be paid, as per Tender agreement.

#### 15. BID Prices

The price of Bid i.e. offer must be made by intending bidder covering all points mentioned in the bid format enclosed in this bid document. The financial offer may be submitted keeping in view the terms and conditions of this bid document.

- (i) ITPO shall reserve the right to verify the operation and performance of the service of work by the Bidder and the Bidder shall permit ITPO to do so. The ITPO will verify/evaluate the information submitted by the Bidder with regard to Bidder's capacity. The Bidder is forbidden to sub-contract the work at any stage without prior written approval in working from ITPO.
- (ii) Response time: The response time of bidder to attend any complaint within two three hours upon/ on receipt of the complaint/ information from the ITPO.
- (iii) The job would be assigned to single applicant, which is the overall lowest bidding Business entity found technically fit for the job.
- (iv) The quoted rates in the Commercial Bid would be valid for two years from its finalisation and award of work as no change in the annual rates would be considered at a later stage.
- (v) Tenders with incomplete information are liable for rejection.
- (vi) Tenders not submitted in the format specified as per the Tender Document will be summarily rejected.
- (vii) Tenders with the Technical Bid without containing Tender Fee in the prescribed format will be summarily rejected.
- (viii) Tenders with incomplete information, subjective and conditional offers as well as partial offers will be liable for rejection.
- (ix) The company should not be previously blacklisted by any Govt./ semi Govt. organization or PSU. (please furnish undertaking as per format).
- (x) The Bidder cannot make any amendment in the Technical Bid/ Commercial Bid, neither can he impose any conditions. All such conditional /amended bids will be rejected at the discretion of ITPO.
- (xi) The bid evaluation would be upon the price, which is exclusive of GST. GST as applicable from time to time shall be paid extra. The bidder shall submit documentary evidence of depositing the GST to concerned authority.
- (xii) The agency should be in a position to cater to any additional requirement of ITPO at a short notice.
- (xiii) In case the requisite Golf Cart is not made available on any particular day, the ITPO will be at the liberty to hire vehicle from any other source at the expenses of the Contractor.
- (xiv) The driver will always keep his registration certificate, valid pollution free certificate, insurance papers and other such documents ready as required by Govt. authority for inspection.
- (xv) ITPO shall not be responsible for damages of any kind for any mishap/ accident/ injury caused to the Golf Cart Driver or any Third person while performing duty for ITPO. All liabilities legal or monetary shall be borne by the Bidder/Business entity exclusively.
- (xvi) No parking charges/toll taxes/ entry taxes State Taxes in connection with the contracted official duty will be paid by ITPO.
- (xvii) The Golf Cart and Driver/staff will not be changed except with the prior consent of supervisory official of the General Section, ITPO.

#### 16. <u>Award Criteria</u>

(i) Preliminary Scrutiny: ITPO will scrutinize the offers to determine that the offer is complete and to find whether required technical documentation has been furnished, whether the documents have been properly signed and whether items are quoted as per the schedule. ITPO may, at its discretion, waive any minor nonconformity or any minor irregularity in an offer. This shall be binding on all Bidders and ITPO reserves the right for such waivers.

(ii) The quote received will be first evaluated for completeness and responsiveness. Only those bids which are found to be responsive, will be considered for Technical Evaluation, those bids which are technically qualified will be considered for financial ranking. Non-responsive / Non- complete bids shall be summarily rejected and no revert or oral communication of the same will be obligatory on the part of ITPO.

#### 17. Payment Terms

- (i) Payment shall be released after successful and satisfactory rendering of the services and submitting the bills. ITPO will process the payment on receipt of the bills as per the procedure and terms & conditions in vogue. The penalties if any would also be deducted due to any unsatisfactory work found after submitting the bill. The bills should have following enclosures
- (a) Proof & payment of ESI & EPF for each staff/driver deployed by the agency.
- (b) GST No. 07AAATI2955C1ZX of ITPO while submitting the bill.
- (c) In case the document stated para 6(a) & (b) are not enclosed the bills will not be entertained.
- (ii) The rates will be inclusive of all taxes (except GST), fees, levies, etc. and any revision in the statutory taxes, fees, etc will be the responsibility of the Bidder.
- (iii) The quoted rates shall remain firm throughout the tenure of the contract and no revision is permissible for any reason.
- (iv) The maximum amount of penalty will be limited to 5% of the Total contract value.
- (v) The contractor has to deposit necessary copy of challan of EPF as well as ESI after depositing necessary amount with the concerned authority for the particular month in which the staff as well as drivers of the contractor carried out necessary work within Pragati Maidan. No payment will be released, if the contractor failed to deposit the above mentioned documents and no request will be entertained by the ITPO.
- **18. Period of Contract:** The period of contract is for **two years**, which is extendable for another one year upon satisfactory services at the sole discretion of ITPO.

#### 19. <u>Indemnity</u>

- (i) The successful Bidder shall, subject to the provisions of the Agreement indemnify the ITPO for an amount not exceeding 1 (one) time the value of Agreement for any direct loss or damage that is caused due to any deficiency in services.
- (ii) The Bidder/Tenderer/Contractor shall indemnify, defend and hold ITPO and its officers/officials harmless against any and all proceedings, actions and third party claims whatsoever whether financial or otherwise, including liability for payment of contributions/dues to EPFO/ESIC/Govt. Departments/Local Bodies/Statutory Authorities etc. at any time during the subsistence of the Agreement/Contract and subsequent thereto relating to the period of Agreement/Contract, arising out of a breach by Bidder/Tenderer/Contractor and/or its subcontractors, agents, employees, drivers etc. of any of its obligations under this Tender/Agreement.
- **20.** <u>Notification Award:</u> The Bidder whose Bid has been accepted shall be notified of the award by the ITPO prior to the expiration of the period of validity of the proposal, by registered letter or by email. The Bidder shall acknowledge in writing, the receipt of Letter of Acceptance and shall send his acceptance to enter into the Contract within 3 days from the receipt of the letter of acceptance.
- **21.** <u>Signing of Agreement:</u> Pursuant to the Bidder acknowledging the Letter of Acceptance, the Bidder and the ITPO shall promptly and in no event later than 10 days from the date of

acknowledgement of the Letter of Acceptance, sign the contract. ITPO shall have the right and authority to negotiate certain terms with the successful Bidder before signing of the Contract. The signing of Contract shall amount to award of contract and the Bidder shall initiate the execution of work as specified in the Contract.

- **22.** Expenses for the Contract: All incidental expenses of the execution of the Contract/ Agreement shall be borne solely by the successful Bidder and such amount shall not be refunded to the successful Bidder by the ITPO.
- **23.** Failure to Abide by the Contract: The conditions stipulated in the Contract shall be strictly adhered to and violation of any of these conditions shall entail immediate termination of the Contract without prejudice to the rights of ITPO.
- **Acceptance & withdrawals:** The right of final acceptance of the tender is entirely vested with ITPO who reserves the right to accept or reject any or all of the tenders in full or in parts thereof without any reason whatsoever. There is no obligation on the part of ITPO to communicate with rejected Bidders. After acceptance of the tender by the ITPO, the Bidder shall have no right to withdraw his tender, or claim higher price.
- **Termination of Contract:** Termination for default, ITPO may, without prejudice, to any other remedy for breach of Contract, by prior written notice of default sent to the Bidder, terminate the Contract in whole without assigning any reason if:-
- The qualified Bidder fails to perform any obligation(s) under the Contract.
- The bidder is in material breach of the representations and warranties contained in this Contract.
- **Arbitration:** In case of any dispute, both the parties shall make all efforts to resolve by way of conciliation process. In the event any doubt, dispute or difference arising out of or in relation to the Contract remains unresolved, both the parties to the Contract will mutually appoint a Sole Arbitrator, in accordance with the Arbitration and Conciliation Act, 1996.

The provisions of Arbitration & Conciliation Act, 1996 (as amended from time to time) shall apply to both the parties.

The fee payable to the Arbitrator shall be paid equally by both the parties. The language used in the arbitral proceedings shall be English.

The venue of the arbitration proceedings shall be the Office of ITPO, i.e. Pragati Maidan, New Delhi.

- **27.** <u>Jurisdiction:</u> All disputes arising out of and in relation to the contract between the parties herein shall be governed by Laws of India, subject to the jurisdiction of the courts of Delhi only.
- 28. Force Majeure: If at any time, during the continuance of this Contract, the performance in whole or in part, by either party, of any obligation under this Contract is prevented or delayed, by reason of war, or hostility, acts of the public enemy, civic commotion, sabotage, act of State or direction from Governmental Authority, explosion, epidemic, pandemic, quarantine restriction, strikes and lockouts(as are not limited to the establishments and facilities of the Parties), fire, floods, natural calamities or any act of GOD (hereinafter referred to as "Event"), provided notice of happenings of any such Event is given by the affected party to the other, within 7 Calendar days from the date of occurrence thereof, neither Party shall, by reason of such event, be entitled to terminate this Contract, nor shall either Party have any such claims

damages/compensation/costs/expenses against the other, in respect of such non-performance or delay in performance provided the Contract shall be resumed as soon as practicable, after such Event comes to an end or ceases to exist. The decision of the CMD, ITPO as to whether the service may be so resumed (and the time frame within which the service may be resumed) or not, shall be final and conclusive, provided further that if the performance in whole or part of any obligation under this Contract is prevented or delayed by reason of any such event for a period exceeding 30 days, either party may, at its option, terminate the Contract.

- **29.** <u>Indemnity:</u>Contractor/Agency shall indemnify, defend and hold ITPO and its officers/officials harmless against any and all proceedings, actions, losses, damages, expenses, costs and third party claims whatsoever whether financial or otherwise, including liability for payment of contributions/dues to EPFO/ESIC/Govt. Departments/Local Bodies/Statutory Authorities etc. which ITPO may sustain, incur, suffer or be exposed to at any time during the subsistence of the Contract and subsequent thereto relating to the period of Contract, arising out of a breach by the Contractor/Agency, its sub-contractors, sub-agents, employees, etc. of any of its obligations under the Contract.
- **30.** <u>Confidentiality:</u> Contractor/Agency shall maintain high level of professional ethics and shall not act in any manner, which is contrary to any laws and/or detrimental to ITPO's interest. Contractor/Agency shall treat as confidential any and all data, information and records, obtained/received in the performance/execution of its responsibilities, in strict confidence and shall not reveal such data, information or records to any other person/party without the prior written approval of the ITPO, even after expiry/termination/determination of the Contract. ITPO shall take necessary legal and other remedial actions for infringement of this clause.
- Intellectual Property Rights: ITPO's name/logo/other IPRs shall be the sole and exclusive property of ITPO only. For any misuse/misrepresentation/unauthorized use of ITPO's name/logo/IPRs by the Contractor/Agency and/or their sub-agents/sub-contractors/employees etc., the Contractor/Agency shall be held solely responsible. ITPO shall not be responsible for any harm or loss caused to any third party because of any such misuse/misrepresentation/unauthorized use of ITPO's name/logo/IPRs. Contractor/Agency shall indemnify ITPO misuse/misrepresentation/unauthorized use of ITPO's name/logo/IPRs and/or any claim(s) relating to infringement of any intellectual property rights committed by them/their sub-agents/subcontractors/employees etc. ITPO shall take necessary legal and other remedial actions, as deemed fit, for such violations.
- **32.** <u>Compliance with Statutory Laws:</u> All applicable laws (Central/State/Municipal/Local Laws etc.) including labour laws must be complied with/followed by the contractor/agency.

#### 33. Disclaimer:

- a. The information contained in this Bid Document or subsequently provided to Bidders, whether verbally or in documentary form or otherwise by or on behalf of ITPO, or by any of its employees, is provided to Bidders on the terms and conditions set out in this Bid document and such other terms and conditions subject to which such information is provided.
- b. This Bid document is neither an agreement nor an offer by ITPO to the prospective Bidders or any other person. The purpose of this Bid document is to provide interested parties with information to assist in the formulation of their proposals for selection pursuant to this Bid. The assumptions, assessments, statements and information contained in this Bid document may not be complete, accurate, adequate or correct and each Bidder should conduct its own investigations and analysis and should check the accuracy, adequacy, correctness, reliability and completeness of the assumptions, assessments and information contained in this Bid document and obtain independent advice from appropriate sources.
- c. ITPO, or its employees, make no representation or warranty and shall have no liability to any person, including any Bidder, under any law, statute, rules or regulations or tort, principles of restitution or unjust enrichment or otherwise for any loss, damages, cost or expense which may arise from or be incurred or suffered on account of anything contained in this Bid or otherwise,

including the accuracy, adequacy, correctness, reliability or completeness of the Bid and any assessment, assumption or information contained therein or deemed to form part of this Bid document.

- d. ITPO may in its absolute discretion, but without being under any obligation to do so, update, amend or supplement the information, its assessment or assumptions contained in this Bid document. Such changes shall be intimated to all the Bidders. In case additional period for submission, if required due to such amendments, is necessitated the same shall be intimated to all the Bidders.
- e. The issue of this Bid document does not imply that ITPO is bound to select or to appoint any Bidder for the contract and it reserves the right to reject all or any of the Bidders without assigning any reasons whatsoever.
- f. ITPO reserves the right not to proceed with the Bidding Process at any time or stage, without notice or liability, and to reject any or all Bid(s) without assigning any reasons whatsoever.
- **Performance Security Deposit**: The successful bidder shall has to furnish Performance Security Deposit of Rs.1,12,0000/- (Rupees One lakh twelve thousand only) in the form of account payee Demand Draft drawn on any nationalized or scheduled commercial bank, in favour of the India Trade Promotion Organisation, payable at New Delhi within ten days after placing award of work. This receipt is only for successful performance during the period of contract. The performance security deposit will be returned within sixty days after successful completion of the contract period and after adjusting dues, if any. Also no further interest will be paid by ITPO to the successful bidder on account of performance security deposit. In case firm/agency may wish to deposit the said performance security deposit by way of RTGS/NEFT. The performance security deposit in any other form such as cheque or by cash will not be accepted under any circumstances.
- **35.** Forfeiture of Performance Security Deposit: In case of any breach or lapse on the part of the Agency/Firm, ITPO will be entitled to invoke the Performance Security Deposit without any objection from the Agency/Firm in any manner. The Performance Security Deposit shall stand forfeited, if a bidder fails to sign the agreement or accept the contract the contract within the stipulated period.

#### **CONDITIONS OF CONTRACT**

- 1. #### **Instructions for Online Bid Submission**

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at: <a href="https://eprocure.gov.in/eprocure/app">https://eprocure.gov.in/eprocure/app</a>.

#### **REGISTRATION**

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: <a href="https://eprocure.gov.in/eprocure/app">https://eprocure.gov.in/eprocure/app</a>) by clicking on the link "Online bidder Enrollment" on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify /nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

#### **SEARCHING FOR TENDER DOCUMENTS**

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. - 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

#### **PREPARATION OF BIDS**

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document Golf Carefully to understand the documents required to be submitted as part of the bid. Please note the number of

covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.

- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN Card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" or "Other Important Documents" area available to them to upload such documents. - 9) Upon the successful and timely submission of bids (i.e after Clicking "Freeze Bid Submission" in the portal), the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- 10) The bid summary has to be printed and kept as an acknowledgement of the submission of the bid. This acknowledgement may be used as an entry pass for any bid opening meetings.
