GENERAL TERMS & CONDITIONS OF SPONSORSHIP FOR IITF- 2015

- 1. The Partner should have prior expertise in handling related/concerned jobs or the company involved in that Business field.
- 2. The Partner needs to give the photocopy of Registration Number/PAN of the Company.
- 3. The Service Partner shall be deemed to have satisfied himself as to the nature of the work, other facilities, the cost of access to the place of work and all other matters effecting the execution and completion of the work.
