The enlistment of the contractors should be valid on the last date of sale of tenders.

In case only the last date of sale of tender is extended, the enlistment of contractor should be valid on the original date of sale of tenders.

In case both the last date of receipt of application and sale of tenders are extended, the enlistment of contractor should be valid on either of the two dates i.e. original date of sale of tender or on the extended date of sale of tenders.

- 1.1 The work is estimated to cost **Rs 1,61,47,000/-** This estimate, however, is given merely as a rough guide.
- 1.1.1. The authority competent to approve NIT for the combined cost and belonging to the major disciple will consolidate NITs for calling the tenders. He will also nominate Division which will deal with all matters relating to the invitation of tenders.
  - For composite tender, besides indicating the combined estimated cost put to tender, should clearly indicate the estimated cost of each component separately. The eligibility of tenderer will correspond to the combined estimated cost of different components put to tender.
- 1.2 Tenders will be issued as per NIT to eligible contractors provided they produce definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works of magnitude specified below:-
  - 1.2.1 Conditions for Non CPWD contractors only, if tenders are also open to non-CPWD contractors.

For works estimated to cost up to Rs.15 Crore. – applicable for this work.

Three similar works each of value not less than 40% of estimated cost or two similar work each of value not less than 50% of estimated cost or one similar work of value not less than 80% of estimated cost (rounded to nearest Rs.10 lac) in last 7 years ending last day of the month previous to the one in which the tenders are invited.

**Note:** For works costing above Rs. 3 crore but up to Rs. 15 crore, when tenders are open to non- CPWD contractors also, then class II contractors of CPWD shall also be eligible if they satisfy the eligibility criteria specified in 1.2.1 above.

1.2.2 Criteria of eligibility for CPWD as well as on- CPWD contractors. For works estimated to cost above Rs. 15 crore. – not applicable for this work

Three similar works each of the value not less than 40% of estimated cost of two similar work each of value not less than 60% of estimated cost or one similar work of value not less than 80% of estimated cost (rounded to nearest Rs. 10 lac) in last 7 years ending last day of the month previous to the one in which the tenders are invited.

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to the last date of receipt of applications for tender

- 2. Agreement shall be drawn with the successful tenderer on prescribed Form No. C.P.W.D. 7/8 which is available as a Govt. of India publication. Tenderer shall quote his rates as per various terms and conditions of the said form which will form part of the agreement.
- 3. The time allowed for carrying out the work will be upto 31.07.2016 from the date of start as defined in schedule 'F' or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.
- **4.** The site for the work is available.

OR

The site for the work shall be made available in parts as specified below:

- 5. Applications for issue of forms shall be received by Manager (Civil) upto 3.00 PM and tender documents shall be issued by Manager (Civil) upto 4.00 PM. Tender documents consisting of plans, specifications, the schedule of quantities of the various classes of work to be done and the set of terms & conditions of contract to be compiled with by the contractor whose tender may be accepted and other necessary documents can be seen in the office of the Manager (Civil) between hours of 11.00 A.M. & 03.00 P.M. from 04.06.2014 to 20.06.2014 everyday except Saturday, Sundays and public Holidays. Tender documents excluding standard form, will be issued from his office, during the hours specified above, on payment in cash as cost of tender as per NIT.
- 6. Tenders shall be accompanied with Earnest money of Rs. 3,23,000/-in cash (up to Rs.10000) demand draft of a scheduled bank issued in favour of India Trade Promotion Organisation, New Delhi. 50% of earnest money or Rs.20 lakh, whichever is less, will have to be deposited in the shape prescribed above and balance amount of earnest money can be accepted in the form of Bank guarantee issued by a scheduled bank having validity for 6 months or more from the last date of receipt of tenders.

The tender and the earnest money shall be placed in separate sealed envelopes, each marked "Tender" and "Earnest Money" respectively. In cases where earnest money in cash is acceptable, the same shall be deposited with the Cash section of ITPO and the receipt placed in the envelope meant for earnest money. Both the envelopes shall be submitted together in another sealed envelope with the name of work and due date of opening written on envelope, which will be received by the Manager (Civil) **upto 3.00 P.M. on 20.06.2014** and will be opened by him or his authorised representative in his office on the same day at 3.30 P.M. The envelope marked "Tender" of only those tenderers shall be opened, whose earnest money, placed in the other envelope, is found to be in order.

- 7. The Contractor whose tender is accepted, will be required to furnish performance guarantee of 5% (Five percent) of the tendered amount within the period specified in Schedule F. This guarantee shall be in the form of cash (in case guarantee amount if less than Rs.10,000/-) OR Demand Draft of any scheduled bank/Pay order of any scheduled bank (in case guarantee amount is less than Rs.1,00,000/-) or Government Securities or Fixed Deposit Receipts or Guarantee Bonds of any Scheduled Bank or the State Bank of India in accordance with the prescribed from. In case the contractor fails to deposit the said performance guarantee within the period as indicated in Schedule 'F', including the extended period if any, the Earnest Money deposited by the contractor shall be forfeited automatically without any notice to the contractor.
- **8.** The description of the work is as follows:

Copies of other drawings and documents pertaining to the works will be open for inspection by the tenderers at the office of the above mentioned officer.

Tenderers are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their tenders as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their tender. A tenderer shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed. The tenderer shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a tender by a tenderer implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.

- 9. The competent authority on behalf of the CMD, ITPO does not bind itself to accept the lowest or any other tender and reserves to itself the authority to reject any or all the tenders received without the assignment of any reason. All tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer shall be summarily rejected.
- **10.** Canvassing whether directly or indirectly, in connection with tenders if strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection.
- 11. The competent authority on behalf of CMD, ITPO reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.
- 12. No Engineer of gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as a contractor for a period of one year after his retirement from Government service, without the previous permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the tender or engagement in the contractor's service.

- 13. The tender for the works shall remain open for acceptance for a period of ninety (90) days from the date of opening of tenders/Ninety days from the date of opening of financial bid in case tenders are invited on 2/3 envelope system (strike out as the case may be) if any tenderer withdraws his tender before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the tender which are not acceptable to the department, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid. Further the tenderer shall not be allowed to participate in the re-tendering process of the work.
- **14.** This Notice Inviting Tender shall form a part of the contract document. The successful tenderer/contractor, on acceptance of his tender by the Accepting Authority, shall, within 15 days from the stipulated date of start of the work, sign the contract consisting of:
  - a) The notice inviting tender, all the documents including additional conditions, specification and drawings, if any, forming the tender as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto.



#### ADDITIONAL CONDITIONS

- 1. The contractor must follow CPWD Safety Code as provided in general conditions of contract for CPWD Works.
- 2. Any damage done by the contractor or his workmen to any existing work during the course of execution of the work shall be made good by him at his own cost.
- 3. Contractor shall clear the site thoroughly of all rubbish etc. left out of his materials immediately on completion of the work and properly clean the site around the building to the satisfaction of the Engg.-in-Charge. Otherwise the site will be cleared by the department at his risk & cost to remove and clean the site.
- 4. The contractor to whom the work is awarded will have to sign the agreement on non judicial stamp papers of Rs.50/- and the cost of such stamp paper will be borne by the contractor.
- 5. All incidental charges of any kind whatsoever including cartage, cutting and wastage etc. shall be borne exclusively by the contractor and nothing extra will be paid to him on this account.
- 6. The agency should ensure nomination of 2-3 officials from their side for undertaking any repair/maintenance of stall work required during the fair period. These officials must be directed to be available in the Mini Control Room to be set up by I.T.P.O. during the fair period.
- 7. The maintenance of Hanger/AC during fair duration is also the responsibility of the agency and nothing extra shall be paid on this account.
- 8. The rejected material must be removed from site by the agency at their risk& cost.
- 9. The security/watch & ward of the materials is the responsibility of the agency.
- 10. The payment will be made on actual work executed at site and as per tender conditions.
- 11. No payment is admissible for the rejected work found during the course of execution of work.
- 12. In case of any defective work which is acceptable with defects, shall be paid @ 30% of the quoted rates. The entry of defective work will be made in the site order book or intimated through written communication
- 13. The contractors are required to submit the bill on their printed letter head having detail of Service Tax No &TIN. As applicable for release of payment.
- 14. The agency has to submit the affidavit that they are having the required quantity of hanger as mentioned against items of International make/Standard. In case the agency is failed to provide the required quantity of hanger of International make/Standard make, the same shall be got executed at their risk & cost through other agency.
- 15. The quantities mentioned in schedule of quantities may vary on either side as per site requirement.

- 1. The Contractor has to design & decide the number of units required for proposed area and intimate to the Engineer-in-charge. However, a package/split unit shall be provided @ 1.0 TR for 7 to 10sq. mtr.depending upon the site conditions.
- 2. Location of the outdoor and indoor units will be decided in consultation with Engineer in-charge. Placement & lifting arrangements shall be made by the contractor at his cost. Nothing extra will be paid on this account.
- 3. In case any unit does not function during the currency of the fair, the contractor has to replace / rectify the defects and make the unit operational within one hours otherwise proportional recovery for each unit for full day for the outage shall be made.
- 4. The contractor should have at site adequate No. of man power such as operator, AC mechanic, Electrician Fitter etc. and Spares like compressors, motors, copper piping, refrigerant and other items required for the up keep and operational of the units.
- 5. The contractor has to maintain  $23 \pm 1$ . 0 Centigrade temperatures inside the conditioned area. The contractor must monitor the temperatures on hourly basis at various locations and keep record of the same. If the temperature is not within the prescribed limits, action to supplement air conditioners will be taken up by the contractor. Nothing extra on this account shall be paid.
- 6. The contractor has to make arrangement for the watch and ward of the equipment installed/spares.
- 7. The installation, testing and commissioning of all AC units must be completed before one day of the event as time is the essence of the contract.
- 8. The contractor has to get acquainted with the height of Hall at various locations in the hall, and accordingly the units must be planned and installed.
- 9. The contractor shall be responsible for safety of the equipment and personal and ITPO shall not be responsibility for this.
- 10. Any damage during installation / operation / removal caused to the ITPO property shall be the responsibility of the contractor. Necessary recovery shall be made on this account from the contractor.
- 11. No power supply will be permitted from inside the Halls for obtaining the air condition connections.
- 12. The Agency shell keeps the units in uniform.
- 13. The Agency shall keep additional units to replace defective one.
- 14. The units may be neatly painted and the switch boxes are properly covered.
- 15. Necessary earthing must be done to all equipments and all safety precautions must to be taken during installation and operation.
- 16. The electrical consumption charges shall be born by ITPO. However the Agency must use energy efficient equipments.
- 17. The rates quoted will be for total fair/event period.
- 18. The required room temperature will be mentioned during the whole Exhibition /event period from which recovery will be made at the quoted rates and 10% as penalty on per sq.mtr. per hours basis of the affected area.
- 19. The duct should be fire retardant suitable to site i/c. hanging arrangements complete as required.
- 20. Cables connected to units/panels should be properly dressed / thimble and properly covered at crossings lane to avoid any accident.
